We are required to mitigate the 'changes' done to the historic nature of the building. These measures are not only needed to bring your building back into a more presentable state, but also to meet our obligation to preserve the history of the Capitol building. In addition to SHPO, at least one of the nine recognized Oregon Tribes has take a significant interest in both archeology and historic elements for Phase III.	NO
Remove additional TV locations in all offices, only have 1 location for TV mounting	\$41,660	Reduces flexibility of office set up with only one wall able to take TV mounting	NO
