**DECLARATION OF BRIAN HUGHES**

I, Brian Hughes, declare as follows:

2. I am currently employed by the City of Portland as a Commander at Central Precinct with the Portland Police Bureau.
3. The ICE facility falls within the jurisdiction of Central Precinct. I have asked the

sergeants to continue monitoring the activity at the ICE facility daily and nightly. Sergeants have been instructed to call the on-duty ICE supervisor near the beginning of each shift to provide them with a C shift and E shift point of contact. A brief synopsis of what was observed is then emailed to me each evening and are maintained as a business record.

Due to the holiday and the larger turnout at today's protest, I assumed responsibility for monitoring the activity around the ICE facility tonight. I contacted FPS Supervisor Will Turner and advised him of the event at Caruthers Park. Turner reported that FPS resources are being pulled back for other priorities in other parts of the country, and that they were down approximately ten of their tactical officers tonight.

At approximately 1730, the gathering at Caruthers Park was estimated at 125 people, about half of whom were dressed in black bloc. Many wore gas masks, though I did not observe shields or other direct-action equipment. The group remained in the park for about an hour for music and speeches before marching south on Moody Avenue to the ICE building. Once there, they coned off the eastbound lane of SW Bancroft, restricting access from Macadam Avenue. All other traffic flowed without issue. Protesters stood in the eastbound lane of Bancroft and on the sidewalk in front of the building with little to no energy. A few positioned themselves near the cones along Macadam, waving signs and flags at passing vehicles.

I spoke with Turner again, and he reiterated that he was not concerned about the group. He stated that his team would remain out of sight unless significant vandalism or life-safety issues occurred.

As the evening progressed, the crowd gradually dispersed. A larger-than-normal group of approximately 50 remained, though their activity level was low and there were no major issues.

Dispatch created an information call (24-239724) and added related calls throughout the night. The only call voiced was at 2140, when Wendy Sletten requested contact. Sergeant Buck spoke with her, and she expressed frustration over what she described as PPB's lack of response. She stated that the protesters were not there to demonstrate but to terrorize neighborhood residents, and that they constantly issue threats, which was the theme of the majority of calls.

As of 2200, about 40 individuals remained in the area, still with low energy and no significant problems observed.

- **22:03** – Caller (Joshua McCoy) reported approximately 12 protesters blocking Bancroft & Bond; optional contact provided.
- **22:08** – Sergeant spoke with Wendy Sletten again; she reiterated frustration, stating multiple incidents have occurred and she feels PPB is not responding.

Will Turner is the OIC this week. I spoke to him a bit about the events the entire week since I was not here Monday and Wednesday.

Labor day they had over 200 protesters in front of the facility. They did several push outs and arrested a few. Most people left after the initial, but had around 100 - 150 loitering around all night. There was significant media coverage around the guillotine.

Tuesday was completely un eventful. No calls for service and around 20 of the usuals.

Wednesday, an unknown subject was flying a drone in front of the upper windows in violaion of the TFR. Agents figured out who the drone operator was, contacted and arrested. The susepect got violent and spit on agents. He was arrestd and booked.

Today, (Thursday) I counted 20 at the beginning of the shift and around 15 at 2030 hours.

Tuner told me they are seeing several older transients that are being cooersed into approaching the gate and causing a distraction or just told to rattel the gate. This was cooberated by watching the instigators escorting different subjects, mostly described as elder transients up to the gate. One one occasion, FPS took custody of an elderly man after he asked the agents if he could just come up to the gate and rattle it so the antifa instigators would leave him and others alone. He was escorted behind the gates and interviewed. He told agents he and several other transients are being coerced to act on their behalf to instigate agent response. The subject was given a cite and released.

Tracy Molina is a daily chronic problem. She is the subject in the flyer from Intel that was carrying what appeared to be a pink synthetic rifle with a Glock pistol that fits in the middle. For those that do not know her, she is a very aggressive 1234 with a military background. She has been arrested more times than one can count and has been excluded and arrested numerous times from city property. She likes to interrupt city council and business at city hall, etc. She can be very violent.

FPS had been looking for her for several weeks as she has made threats to ICE agents and has expended her three strikes at the facility. She was arrested and escorted in the building. She cut her arms in the holding cell and graffitied the wall with a lot of blood before being taken to the hospital. FPS executed a warrant on her apartment and later lodged at jail pending

Federal charges. She is on supervised pre trial release with a no contact at ICE restriction.

As of 2100 hours tonight, there have been no calls for service and no reportable activity at the facility. There is an elderly Alaskan male (Daniel Cox) at the facility who has some severe medical issues with his legs (Infection/MRSA) that is a chronic. He knows jail will not take him if arrested and is therefore empowered to stay and be a problem.

Good Evening,

This was an extremely busy shift tonight for all three precincts. We started the shift in great shape with only -7. North and East were way worse off with -8 each.

I drove by ICE around 1600 hours, saw one person standing and one person passed out on the concrete wall in front of the building. I contacted OIC Turner.

East had a horrible double homicide/suicide, a potential fatal/trauma crash and normal business. North had the missoin with all RRT resources.

Central started the shift with a 1234 subject who jumped off the Hawethorn Bridge after taking a header into an oncomming car.

North had a fatal crash on I5/Rosa Parks at around 2300 just as we were cleraring a tactical call. The IMT held all of C shift citywide over for two hours.

At around 2100, I received a call from OIC Turner letting us know there were over 50-60 very active protestors/black blockers/agitators at the gate who were very active. Lots of noise, flashing lights, some were swinging sticks. The crowd was very energized. I drove by just as FPS was pushing out in order to get some vehicles in. I noted well over 50 people in front of driveway as well as all four corners of S. Bancroft/Moody. The conditions were the same at 0030 hours after speaking with OIC Turner.

They have 26 agents on until 0100 and 7-8 overnight.

- Drove by at 1800, 2030, 2130
- At 1800, about 15 individuals. Most were across the street from ICE, with a few near the trolley.
- 1835 – 25-247302: Related to ICE protests. Report of a female swinging at others and pulling out mace but not deploying it. Description: White female, 50s, green/gray hat, t-shirt with lion graphic, black leather jacket, blue jeans. Caller mentioned she was antagonizing protest “influencers,” but details were hard to hear due to yelling.

Officer Leepert spoke to the caller (not the victim) and advised separating from two journalists.

- 1858 – 25-247318: Appears related to 25-247302. From FPS dispatch: Counter-protester sprayed someone with mace. Suspect: unknown race female, green hat, black leather jacket, brown shirt underneath, blue jeans. Possible victim: female, black bandana, green/black top, gray pants. Both parties reported to be in front of the vehicle gate. FPS officer asked complainant to call it in. No weapons observed, no medical needs reported. Fire responded, but no victims came forward.
- 2030: I observed a group of about 30, mostly dressed in black. Some right in front of ICE, some across the street. No energy.
- 2105 – 25-247410: Disturbance reported by FPS. Female surrounded by 10–12 protestors and backed into a corner. Earlier in the evening, she had used pepper spray against some protestors. Description: White female, heavy set, green hat, brown shirt, blue jeans. No victims called.
- 2118: I observed approx. 15 people in all black clothing and black helmets. About 15 others across the street, and around 5 near Macadam. No active disturbance.
- FPS supervisor kept me updated throughout. He advised the incidents primarily involved two females.
- Last update was of Fire, who responded for the counter-protester. As of this notification, no victims have reported.

25-252398- caller from the Oregonian received an email with screenshots from facebook about a mass shooting that was going to happen tonight. That post circulated and we believe is responsible for the increased number of people at ICE tonight. CIU was notified and Freidman took this over.

25-252428- caller reporting a known subject with an extended magazine was going to instigate a fight with protesters in order to then shoot them. The named subject was known to CIU from a previous TARP referral and Jason Wands took over that investigation.

25-252549- a vehicle with no plates confronted the protesters and eventually pushed someone yelling back at him. The driver also discharged pepperspray prior to leaving the scene. No one needed medical. Sgt. Schaaf contacted me and said RRT has dealt with this individual in the Nissan at other events. He is looking for that information for the PC.

No significant activity observed today. I drove past the location throughout the night and noted approximately 10–12 individuals present.

Turner, the contact on site, confirmed that no issues required a response outside for their officers. He reported their numbers peaked at around 15 people during the night.

Additionally, I observed a male in a wheelchair at the corner of Macadam and Bancroft holding a sign reading “100 Days of ICE Protest.” He did not react as I drove past.

The only call received today was 25-254689, a follow-up request for a supervisor regarding a prior issue. I attempted to return the call, but the number produced an error message. Dispatch verified the number and confirmed it was correct via listening to the call again. I cleared the call and notified A/Lt. Lloyd in case they call back.

I was the ICE contact tonight. Just an FYI- Will Turner is back for the next bit down there.

We have several holding calls however due to multiple stabbings (25-255788), we are not responding and they are holding for nights. As of leaving tonight- these calls are holding.

25-255574, this is the 4<sup>th</sup> call from this person asking for follow-up from a macing on 9/8 (not police involved). Multiple sergeants have called her because she is displeased with her police service however the calls do not go through. I attempted as well and the number does not work. There is yet another call holding from this person. I did look into the incident and couldn't find a report so I contacted Turner and his people are looking for video. I foresee this gal being a bit of a stinker about not getting a report taken but I hope at least having the video can help mitigate.

25-255794, holding disturbance for someone shouting at a woman at the protest. Everyone is safe and separated. We have no officers to go or call.

25-255798, holding harassment for a protester that is being followed and yelled at by another protester who has assaulted her in the past. Caller left and wants phone contact. Holding for nights (I am curious if these last two calls are related).

There are approximately 50 people in front of the building. They have been periodically blocking the streets for dancing. Turner said they were having a "pinata" party earlier but I did not see that. There is more energy that I have seen in the past couple weeks. Most people are blocked up and a lot of stuff has been brought in- cases of water/ drinks, boxes around, etc. Turner said they had intel about a proud boys gathering/ vigil that would come attempt to engage with the group, possibly leading to the bolstered numbers. As of leaving tonight- there has not been a confrontation like that.

Summary: At 2258 hours, FPS dispatch alerted BOEC to verbal disturbance in front of ICE between a group of protesters and a couple of counter-protesters. At the time, the precinct was on priority 1-2s with few to zero officers available due to a near fatal assault in Central and a shooting with multiple victims in East. Around 2337 hours, FPS updated that became physical. At 2346 hours, officers got eyes on ICE and reported no active disturbance and no involved parties flagging them down.

FPS later provided BOEC with the counter-protester's name. An officer later called him once the precinct went back to all calls. Amacher reported that he went to ICE to escort a couple of other counter-protesters away from the crowd. A subject in all black tried to take Amacher's walking stick, then they both fell over. Another subject pepper-sprayed Amacher on the ground and 15-20 people surrounded him. FPS or other federal officers deployed munitions to break up the crowd, allowing Amacher and his friends to get away.

No arrests have been made and video is pending.

FPS Agents were busy tonight. There was a group of 50 at the facility. Due to short staffing, lots of calls and a major crime scene I was on the entire night, I did not drive by, however Sgt. Duarte did. Again, once a marked car drives through, they will flip off, scream and throw objects at the car and in most cases run towards the car as if they are going to charge the car.

FPS Will Turner called me throughout the night with info about black blockers assaulting people. We were on Pri 1-2 with 50-60 calls holding, however only got one call from someone reporting they were assaulted on Saturday.

I received video from FPS and a report about a journalist who was assaulted by a black blocker with a large sword or stick. VI is Rhein Amacher and suspect is Seth Sinclair. They are known to FPS as Seth is a nightly agitator that has been cited by FPS.

I set up a call (25-259060) for nights to att contact and make a report. The other call is (25-258940).

To be clear, even if these folks were still at ICE or nearby, we would not be able to address the call or make an arrest with the resources we have.

Summary: FPS dispatch alerted BOEC to a disturbance in front of ICE between 12 protesters and one counter-protester (Amacher). One protester pepper-sprayed Amacher. FPS updated that the same protester pepper-sprayed another counter-protester. Video from FPS helped to establish PC for Attempt Robbery II and Unlawful Use of Pepper Spray. There were as many as 50 protesters gathered, and more agitated than most nights, so I requested a MFF from East to assist us. Once we had all of our resources and a solid plan in place, officers searched for the suspect while avoiding a confrontation with the main crowd. Ultimately, the suspect was not located, but FPS noted that the crowd's demeanor shifted and they began to break up after police drove threw the area a few times.

Units Notified: Major Crimes via email, due to the robbery charge.

Outstanding Action Items: Perry or Kenney, can you please send a Dayshifter to pick up the full video from FPS in the morning? They should have it earmarked.

These 3 counter-protesters continue to be a chronic source of police and medical calls at ICE. Despite repeated advice from officers to stay away from the ICE crowd, they constantly return and antagonize the protesters until they are assaulted or pepper sprayed. They refuse or are reluctant to walk away from these confrontations, even when police are in the area trying to meet with them. They even engage in the same trespassing behavior on federal and trolley property as the main protesters. Aside from the confrontation between opposing protesters, there was no reported activity around ICE that would have otherwise generated a police response.

Initially I lead the team of custody cars for the planned demonstrations today (ICP) . Observed both the Square and ICE and found no issues. Throughout the day we observed approximately 8-15 people at any given time out front of ICE. Mostly sitting in lawn chairs and walking around. Energy was low, minimal activity. As officers drove through the area the group would often flip us off but as the night went on they stopped acknowledging the police. No changes at the time of demobilization at 2100 hours. As of this email no reported incidents and nothing from ICE.

I also clarified with Eric Johnson, the Regional Director for FPS regarding the "Surge" in officers at their location that was previously reported by Sgt. Edwards. He clarified for me, that he decided to bring in 8 additional FPS officers from the region last night to pre-emptively staff up, should something unexpectedly happen. There was nothing planned and no specific reason he was just ramping up staff considering the events that took place this week. Eric said several of those officers have already left Portland back to their respective offices.

Early on the crowd was 5-10 people standing around, low to no activity. I spoke to our contact Eric Johnson at approximately 1800 hours, he had no issues, no concerns. At 2030 I drove through again and noticed a larger crowd of approximately 50-60 people spread out on every corner and in the driveway. I called Eric again and he explained that a larger group arrived and started blocking their driveway, yelling and refusing to comply with their orders to leave. FPS came out and arrested one subject for blocking as they were attempting to have vehicles leave. I stayed in the area and continued to monitor. Air One attempted to help gauge the size of crowd and demeanor; they gave a brief update saying crowd size was approximately 30-50 before reporting they had to leave that air space. Unknown why exactly... It should be noted that a larger helicopter (unknown if it was military, federal or private) was actively flying around the city and in the area of ICE at this time.

Checked the area again at 2300 hours and crowd size was the same. Called Eric again and he said crowd was mild. No activity since they made their arrest earlier in the night. As of this email no calls for service related to ICE and nothing from ICE directly.

Summary: FPS reported a 20 vs. 1 fight was occurring just east of the ICE building on Bancroft St. As officers responded to the area, the 4 victims called in. Moore and Oliva were observing the protest as Moore livestreamed with her phone. When the protesters burned an American flag, Moore and Oliva expressed their displeasure to the crowd. A verbal argument escalated and crowd members started pushing Moore. Oliva intervened to protect her, and crowd members assaulted and pepper sprayed him. Ralph and McFarland are area residents and were walking by the protest to see what was going on. They witnessed Oliva being assaulted. Ralph attempted to intervene and was also assaulted. McFarland was surrounded by protesters and felt she was being intimidated and unable to leave. All 4 were eventually able to leave the area; a protester broke the driver's window of Oliva and Moore's car as the drove away.

Ralph had minor injuries and declined medical. Oliva was bleeding heavily from his face, was evaluated by AMR, and declined transport. Oliva and Moore were able to give descriptions of 3 suspects, but did not have video or photos. FPS did not capture the assault on their cameras.

There were 50-60 protesters outside of ICE at the time. Most of them were blocking the facility's driveway in anticipation of the shift change. Many were dressed in bloc, with helmets, masks, and other PPE. We did not have enough available officers to form a MFF due to other ongoing priority calls (including a robbery with a firearm and assaults around the entertainment district). The described suspects were not visible when we drove by the fringe of the crowd.

Additionally, FPS requested PPB's assistance with facilitating getting their vehicles out of the facility for shift change. They had the resources to clear their driveway, but were concerned

about protesters shining bright lights at them as they drove out. Regional Director Eric Johnson claimed that the Chief and/or AC Dobson told him 2 weeks ago that PPB could position marked cars at Macadam/Bancroft to deter the crowd during shift changes. I was not sure if that action would conflict with previous direction to not assist with facilitating the movement of vehicles in and out of the facility; regardless, we did not have the resources to safely accomplish that task for a crowd of this size and demeanor.

We received no further calls after shift change. Priority call load did not afford an opportunity for us to monitor the area later in the night.
